CRS Controlling Person Self Certification Form 控制人税收居民身份自我声明表格 Please read these instructions before completing this form 请于完成表格前阅读此份说明

## Why are we asking you to complete this form? 我们为何需要您完成这份表格?

To help protect the integrity of tax systems, governments around the world are introducing a new information gathering and reporting requirement for financial institutions. This is known as the Common Reporting Standard (the CRS).

为协助打击逃税,维护税制完整,全球各地政府现正推出适用于金融机构的资料收集及汇报新规的要求,名为共同汇报标准(简称"CRS")。

Under the CRS, we are required to determine where you are "tax resident" (this will usually be where you are liable to pay corporate income taxes). If you are tax resident outside the country/jurisdiction where your account is held we may need to give the national tax authority this information, along with information relating to your accounts. That may then be shared between different countries'/jurisdictions' tax authorities。 CRS 规定,我们必须确定您的"税收居民身份"(通常是您有义务缴纳所得税或公司税的国家 / 地区)。若您的税收居民身份或纳税地有别于开户所在地,我们或将此情况以及您的账户资料告知您账户所在国家 / 地区税务机关。相关资料或由您的税收居民身份所在国家/地区或多个国家 / 地区税务机关共享。

Completing this form will ensure that we hold accurate and up to date information about your tax residency. 完成此表格可以确保我们持有您的准确、及时的税务居民信息。

If your circumstances change and any of the information provided in this form becomes incorrect, please let us know immediately and provide an updated self-certification.

## Who should complete the CRS Controlling Persons Self Certification Form? 谁需要完成这份 CRS 个人自行声明表格?

When an account is held with Hang Seng Bank (China) Limited on behalf of a Passive Entity (for example certain trusts or investment vehicles) we need those individuals identified as having ultimate control of the entity to complete a form. These individuals are termed "controlling persons".

当所在恒生银行(中国)有限公司的账户的账户持有人是被动实体(例如某些信托,或者投资工具)时, 我们那些对这些实体拥有最终控制权力的个人填写本表格。这些人称为"控制人"。

Even if you have already provided information in relation to the United States Government's Foreign Account Tax Compliance Act ('FATCA'), you may still need to provide additional information for the CRS as this is a separate regulation.
